Brief History of Amanita

- Known as 'Fly Agaric' for its insecticidal properties in some cultures.
- Sacred use by indigenous Siberian tribes, particularly by shamans for spiritual journeys.
- Features in various folklore and myths across Europe and Asia. • Historically used in Europe for its psychoactive effects during
- religious festivals.
- Possible connections to ancient Hindu texts describing the divine Soma.
- Symbolic appearances in Christmas traditions and fairy tales.



Brief History of Psilocybin

- Central to spiritual and religious ceremonies of indigenous Mesoamerican cultures.
- Aztecs named it 'Teonanácatl' or 'flesh of the gods'.
- "Rediscovered" by Western science in the 1950s by R. Gordon Wasson -->
- Little credit given to curendera Maria Sabina of Huatla de Jimenez, Sierra Mazateca area of Oaxaca for introducing Wasson in 1955.
- Subject of early psychedelic research in the 1950s and 1960s
- Ban in the late 20th century under the War on Drugs.
- Recent resurgence in academic and medical interest.




Pharmacology of Amanita

- Main actives are isoxazole alkaloids
 - Ibotenic acid (active on glutamate receptors)
 - Muscimol (effects GABA receptors)
- Other compounds are present (such as muscarine)
- Ibotenic acid readily undergoes decarboxylation to muscimol
- Complex effect of opposing systems
 - glutamate--> excitatory
 - GABA --> inhibitory
- Considered dissociative deliriant vs. traditional hallucinogen
- Rare toxicity treatment complicated by complex status



Pharmacology of Psilocybin

- Present in more than 200 species of fungi, with the list growing
- Psilocybin is a tryptamine of the indolamine family.
- Biologically active molecule is psilocin
 - Psilocybin (relatively stable) undergoes rapid dephosphorylation to psilocin, much less stable.
- Classical psychedelic related to serotonin with activity at multiple receptors and systems
 - Hallucinogenic effects attritbuted to 5-HT_{2a} activation
- Less studied alkaloids include baeocystin, norbaeocystin, norpislocin, aeruginascin
- Beta-carbolines with potential MAOI effect in some species which may boost activity of tryptamines.



Amanita: Modern Cultural Significance

- Currently not classified as a controlled substance in most countries, leading to legal ambiguity

Psilocybin: Modern Cultural Significance

• Microdosing trends in Western cultures for improved mood and creativity

• Ongoing research into therapeutic uses for mental health issues • TRD, PTSD, AUD, Fragile X syndrome, MDD, fibromyalgia, anorexia nervosa, GAD (source: Psychedelic Alpha drug dev tracker)

• Societal shift towards decriminalization and medical research

- Featured in documentaries, books, and public discourse on mental health
- Evolving as a tool for personal growth and psychological healing
 Increasingly accepted in mainstream culture for potential health benefits

History & Ethnomycology

DIY Mycology

- Surge in home cultivation of mushrooms, supported by online resources and kits.
 Role of social media in spreading mycology as a hobby and science.
 Communities sharing techniques, success stories, and safety tips.
 Small scale to underground industry
 "For microscopy use only"

Quote from KOB4 1/15/22: "In 2005 the New Mexico Court of Appeals overturned a conviction of one man who was charged with trafficking psychedelic mushrooms. Which many argue means you can legally grow magic mushrooms in your home for personal use."

The Microdosing Trend

- Increasing popularity of microdosing psilocybin for mental clarity, creativity, and emotional balance as a part of wellness and self-care routines.
- Anecdotal reports and emerging scientific studies on its effects.
- Popularized by Dr. James Fadiman and Paul Stamets
- Intended to be subperceptual
- The Fadiman Protocol: Subperceptual dose Q 3 Days
- The Stamets Stack: 0.1-0.2g dried mushroom + 500-1000mg dried lions mane mushroom extract or powder + 25-50mg FLUSHing niacin. Used Days 1-4, weekly with non-dosing days on day 5-7
- Lack of defined "microdose," many likely "mini-dosing"
 Huge rise in "microdose" coaching and related services
 Amanita microdosing is also an early trend.

Diverse Communities

Indigenous cultures have long used psychedelics and many individuals are seeking to reconnect with their heritage and reestablish (and reimagine) ceremonial practices that colonialism destroyed.

It is unclear how widespread traditional psilocybin mushroom use was among indigenous Americans outside Central America. Nevertheless, they have an important role as <u>entheogens</u> in indigenous cultures.



Safety Testing


Psilocybin mushrooms have been largely free of adulteration.

Until recently, mostly "small" growers/word of mouth.

- For whole mushrooms, improve safety with quantitative testing to prevent excess dosing "Q-Tests"

Amanita muscaria is generally very easy to identify/verify in raw/dried format. There is no common method for potency testing.

Safe Sourcing & Risks

Riding the hype and the cusp of legality

- Ambiguous and excessive claims
 Deceptive marketing designed to play on the want for "legal" psychedelics
- Synthetics (like 4-AcO-DMT), cannabinoids, and unknown blends of "research" compounds
 Synthetic muscimol and ibotenic acid

Strengths and composition highly variable and unknown




